With funding from NHGRI, he and his team developed the QDS Toolkit, which offers guidance and resources for qualitative data sharing. Dr. DuBois will address questions and concerns that have been raised by the

Health Equity (12/3): The subcommittee met and discussed ongoing projects. Hyoshin
Kim outlined next steps for the analysis of health literacy and members volunteered to be
the point-of-contact from each site. The subcommittee brainstormed future guest speakers

- and decided that in 2025, members will all give 5-minute informal research presentations.
- Participant Engagement (12/12): The subcommittee met and hosted a senior scientist from the Behavioral Research Program at the NIH, Dr. Paul Han and his colleagues who provided background information on the Maine Cancer Genomics Initiative and summarized their behavioral studies on uncertainty. The subcommittee also discussed the nomination process for new co-chairs.
- Return of Results: The subcommittee did not meet this month.
- Genomic Data Commons (GDC) Data Sharing Subcommittee: The subcommittee did not meet this month.
- Non-Genomic Data Sharing Subcommittee (12/2): The subcommittee had its first meeting to discuss future objectives. Members will engage with their respective sites to discuss the completion of an ongoing study and data inventory, as well as to identify specific needs and possible repositories for sharing qualitative data.
